MEMBER ARTIST CONTRACT

- 1. Artist membership is a 1 year commitment and is automatically renewed annually from the date of this agreement unless gallery or member provides written notice of intent to not renew at least 30 days prior to renewal. Membership is subject to jury criteria and guidelines. River Canyon Gallery Board (RCG) retains the right to terminate contract early if artist fails to comply with this contract. Artist terminating association with the gallery prior to the one-year commitment will be required to pay rent due for the remaining term of the contract. If artist requests an early release and if there is a wait list of jury-approved artists, a substitution of artist may be made upon the approval of the RCG Board to fulfill remainder of exiting artist's commitment.
- 2. Artist Members are required to pay a monthly rent of \$50.00, and an annual membership fee of \$50.00, of which \$10 is utilized to pay the Artist Members annual membership into the Cultural Council of Park County. The monthly rent is due each month by the 25th of the preceding month and may be paid in advance. A \$10 late fee will be assessed if rent is not paid by the 25th. These fees are set by the board as determined by the cash flow needs of the gallery and is subject to change upon board approval.
- 3. All work displayed must be gallery quality and consistent with the work that was juried. Artist shall maintain a full slate of inventory within the gallery at all times. Display requirements are governed by Display Committee for the purpose of maintaining consistency of all displays within the Gallery. Display spaces will be determined by the artist's medium and size of art and all spaces may not be the same in size. Artist shall carry their own insurance or self-insure for loss and damage to their artwork. The gallery will not be responsible for damage to or theft of artwork.
- 4. On average each artist must work two days per month and will be modified from time to time as determined by the number of artist members in the gallery.
- 5. RCG retains a 25% commission on sales. Artists are paid by the 25th of the month for the previous month's sales. RCG shall collect and remits sales taxes.
- 6. Artist Members must serve on a committee as determined by the Board and the Artist and will attend a one-day training session before working in the gallery.
- 7. As an artist member, benefits are available and requirements must be fulfilled. These benefits and requirements may change based upon the structure, membership votes, and needs of the gallery. Membership benefits are available to artist members who fulfill their annual commitment and contract requirements. Please refer to the application and addendum attached hereto for more specific information.
